For the purpose of Audit and Circulation of the Annual Financial Statements to the members, the books of accounts have been closed on 31st December 2014.

The Income over Expenditure for IAGZ exceeds by the amount of:

Payables (worth CHF 1,212.00) - details on Balance sheet.

Payables from 2013 (worth <u>CHF 2928.45</u>), out of which CHF 1,236.00 has been paid off. The remaining amount was realised as income as it was overestimated part of provision made last year. More details in balance sheet.
